I understand that my season badge is NON-TRANSFERABLE and NON-REFUNDABLE. If the badge is altered or used by anyone else, it will be immediately and permanently revoked. A **Full Season Pass** is valid anytime the slopes are open, **Weekday Season Pass** is valid all day Monday-Friday (including holidays). A **Peak 5 Pass** is good for five lift tickets to be used by anyone, anytime. **Lesson packs** include 8 group lessons given on the day and time noted on pass (lesson times are listed above). My pass must be visible to lift operators and management whenever I ski/ride. I understand that a daily lift ticket must be purchased if I leave my pass home. If the pass is lost or stolen, there will be a \$40 replacement fee. Once my pass is issued, it is my responsibility to use it as stipulated. I further understand that I will be expected to ski/ride within the safety requirements and obey the rules and regulations of New York State and Peek'n Peak.

NOTICE

SKIERS AND SKI LIFT PASSENGERS

Notice: Skiers and Ski Lift Passengers are governed by the New York State Safety in Skiing Code (Article 18, of the NYS general obligations law).

Before accepting this pass or allowing this pass to be affixed to your person, your attention is directed to a posted “WARNING TO SKIERS” which is printed below and where lift passes are purchased. New York Law requires you to seek out, read, review and understand the “Warning to Skiers” before you desire to participate in the sport of skiing.

WARNING TO SKIERS: Downhill skiing, like many other sports, contains inherent risks including, but not limited to the risk of personal injury including, catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions, or surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps, or other persons using the facilities: or rocks, forest growth, debris, branches, trees, stumps: or other natural objects or man made objects that are incidental to the provision or maintenance of a ski facility in New York State. New York Law imposes a duty on you to become apprised of and understand the risks inherent in skiing, which are set forth above, so that you make an informed decision whether to participate in skiing notwithstanding the risks. New York also imposes duties upon you, to which you must adhere for the purpose of avoiding injury caused by any of the risks inherent in skiing. If you are not willing to assume all of these risks and abide by these duties, you must not participate in skiing at this area.

I have read and understand the notice printed above. I have read, reviewed and understand the “WARNING TO SKIERS” printed above. I signify that I am aware of and understand the risks inherent in the sport of skiing as set forth on the “WARNING TO SKIERS”.

I agree that this acknowledgment shall be for the entire term of the pass or documents received. For the entire term, I relinquish my right to a refund of the purchase price of the pass or other documents purchased that is allowable under the Safety in Skiing Code for those persons unwilling to ski because of the risks of the sport or of the duties imposed upon skiers by law.
